Completion of the purchase of the premises took place on 1 April 2011 and during the five years to 31 March 2016 the necessary renovation and restoration work on the premises have been substantailly completed.

At the date of this report, the premises are in 100% occupation.

The premises offer new commercial opportunities for local businesses and employment possibilities for around 30 people.

SOSCIC won the Wiltshire Council Voluntary and Community Award 2012 for Community Leadership.
