ROAD TRAFFIC REGULATION ACT 1984

1. THE COUNTY OF WILTSHIRE (VARIOUS ROADS, SHERSTON)
(20MPH SPEED LIMIT) ORDER 2025
2. THE COUNTY OF WILTSHIRE (B4040 EASTON TOWN, SHERSTON)
(30MPH SPEED LIMIT) ORDER 2025
(Previously advertised as 2024)

NOTICE IS HEREBY GIVEN that on 9th July 2025 Wiltshire Council made the above mentioned Orders under the Road Traffic Regulation Act 1984 the effect of which is as follows:

Order 1

- a) To revoke The County of Wilts (Restricted Roads) (No.14) Order 1966 and The County of Wilts (Knockdown Road, Sherston) (Restricted Road) Order 1971;
- b) To amend The County of Wilts (Built Up Areas) Order 1936 (No.2) by the deletion from the Schedule of the following lengths of roads:

Malmesbury-Acton Turville road (B.4040) from a point 270 yards west of the Easton Town Cross Roads, where it is intersected by the Easton Town-Westonbirt Road, to a point 10 yards west of Sherston Mill Bridge. A length of 772 yards.

Unclassified road known as Sandpit Lane north-westwards from its junction with route B.4040 for a distance of 134 yards.

Unclassified road north-westwards from its junction with route B.4040, to a point 25 yards south of the junction with the unclassified road known as Green Lane. A distance of 281 yards.

Unclassified road, southwards from its junction with route B.4040, towards Alderton, to the bridge near the Corn Mill at Sherston. A distance of 367 yards.

- c) To introduce a 20mph speed limit on the following lengths of roads in **Sherston**:

Anthony Close – the complete length

B4040 Church Street – the complete length

B4040 Easton Town – from a point 17 metres north east of its junction with Sandpits Lane to its junction with B4040 Church Street

B4040 High Street – the complete length

B4040 Brook Hill – from its junction with B4040 High Street to a point 54 metres west of its junction with Sherston Mill Bridge

Bustlers Hill – from its junction with Tanners Hill and Thompsons Hill for a distance of 120 metres in an easterly direction

Butlers Close – the complete length

Cliff Road – the complete length

Commonwood Lane – from its junction with Thompsons Hill for a distance of 11 metres in a southerly direction

Court Street – the complete length

Gaston Lane – from its junction with B4040 Church Street to its junction with Easton Square

Green Lane – the complete length

Grove Road – the complete length

Knockdown Road – from its junction with Green Lane to a point 79 metres north west of its junction with Sandpits Lane

Manor Close – the complete length

Noble Street – the complete length

North End Gardens – the complete length

Sandpits Lane - the complete length

Saxon Close - the complete length

Silver Street - the complete length

Strong's Close - the complete length

Swan Barton – the complete length

Tanners Hill – the complete length

Thompsons Hill – from its junction with Tanners Hill and Bustlers Hill to a point 102 metres south of its junction with Commonwood Lane

Woods Close – the complete length

Order 2

To introduce a 30mph speed limit on the following length of road:

B4040 Easton Town – from a point 17 metres north east of its junction with Sandpits Lane to a point 32 metres north east of its junction with Tetbury Road

Any person aggrieved by the Orders and desiring to question the validity of the Orders or of any provision contained in the Orders on the grounds that it is not within the powers of the relevant Section of the above Act or on the grounds that any requirement of that Section or of Part III of Schedule 9 of the Act or any regulation made under the said Schedule, has not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.

The Orders will come into operation on 21st July 2025.
